CARES Act Reporting Information

- 1.) On July 30, 2020, Scott Budelmann, the District Superintendent of Madison-Oneida BOCES signed the Funding Certification and Agreement for the Emergency Financial Aid Grants to Students under the Coronavirus, Relief, and Economic Security (CARES) Act. This acknowledgement was signed and returned to the Department through the grants.gov website on July 30, 2020.
- 2.) Madison-Oneida BOCES received notification the amount of \$44,824.00 had been deposited into the G5 account on August 4, 2020.
- 3.) On August 19, 2020, checks were distributed to forty-one students totaling \$43,756.84.
- 4.) On September 2, 2020, a check was sent to one student in the requested amount of \$1,000.
- 5.) The estimated total number of students at Madison-Oneida BOCES eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 180004(a)(1) of the CARES Act is forty-two (42).
- 6.) The total number who received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Act is 42.
- 7.) The funds received were distributed equally among all students who qualified.
- 8.) Every eligible student was sent an email with a description of the grant. The email has been copied and pasted below:

Madison-Oneida BOCES (MOBOCES) along with all other Higher Education Institutions in this country, have been awarded money through the CARES Act Grant funded by the Federal CARES Act stimulus package. MOBOCES has been allocated \$89,648.00 under the CARES Act which became law on March 27, 2020. Half of this allocation, \$44,824.00 must be used for providing emergency financial assistance to students for their expenses related to the disruption of campus operations due to the coronavirus pandemic, such as food, housing, course materials, technology, health care and childcare expenses.

Students who are currently enrolled in a Title IV Eligible Training Program (Practical Nurse) can be awarded grant money through the CARES Act. Students must have satisfactory academic progress.

The Financial Aid Office has worked with Administration as to how the student relief grant money will be distributed.

The maximum amount for PN students is \$1,067.24. You do not need to disclose specifically how you will spend the grant money.
